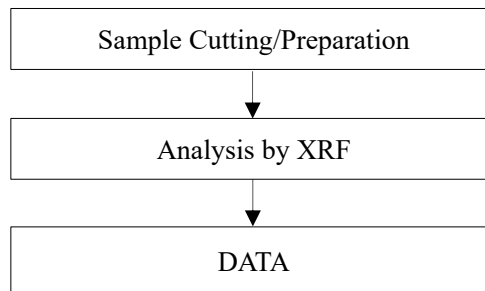

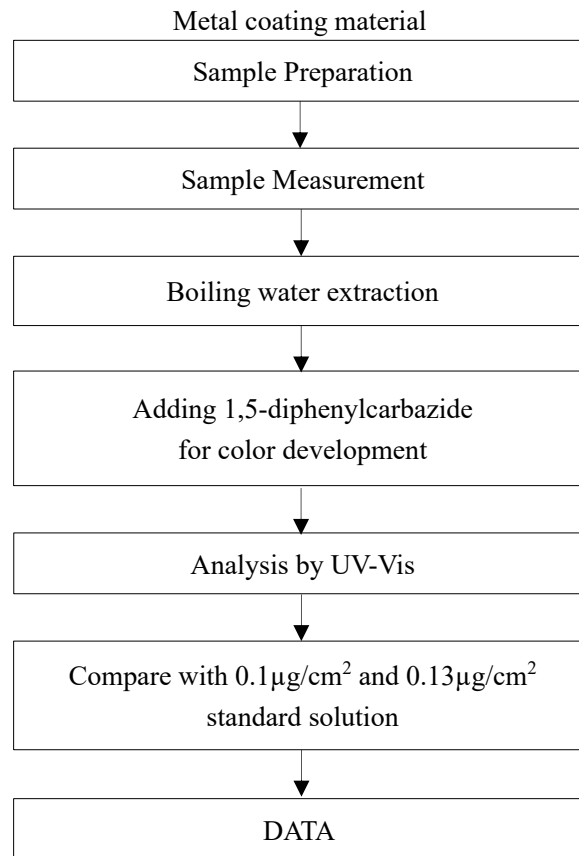

Test Flow Chart of Hexavalent Chromium (Cr⁶⁺)

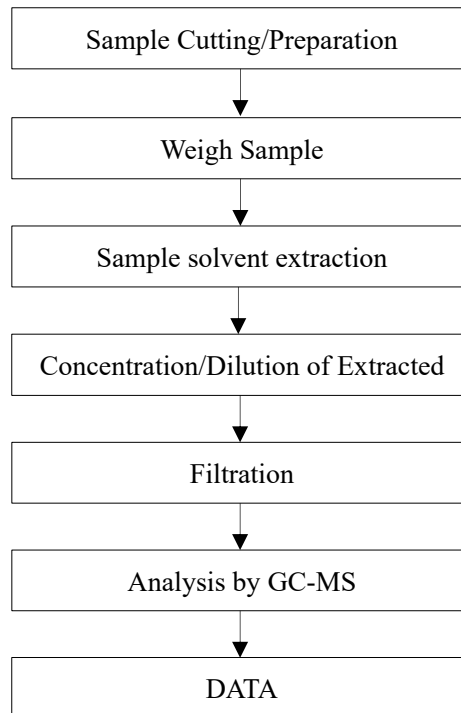

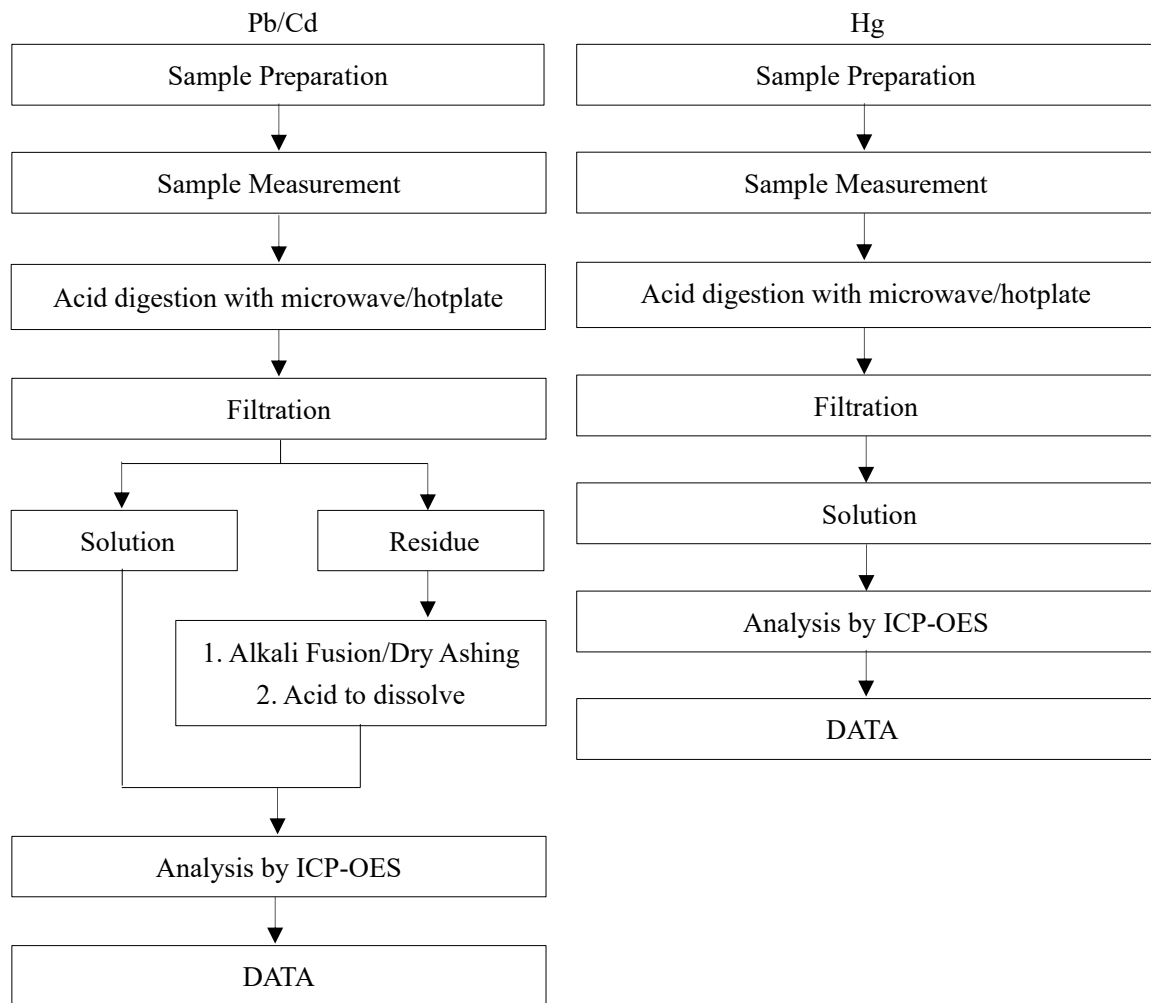

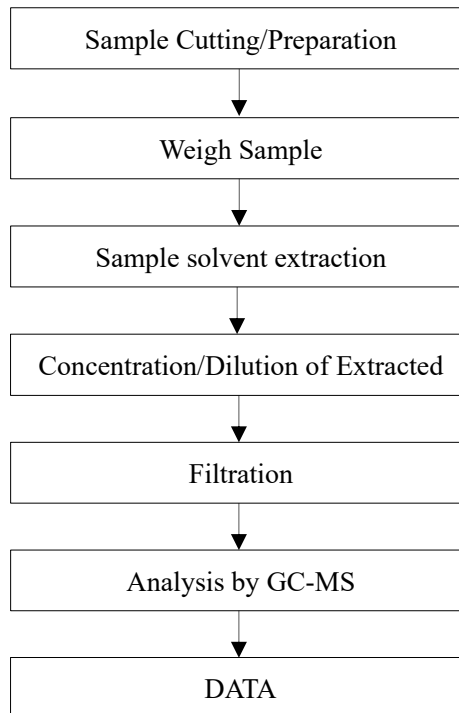
Test Flow Chart of Lead, Cadmium and Mercury

Test Flow Chart of Phthalates



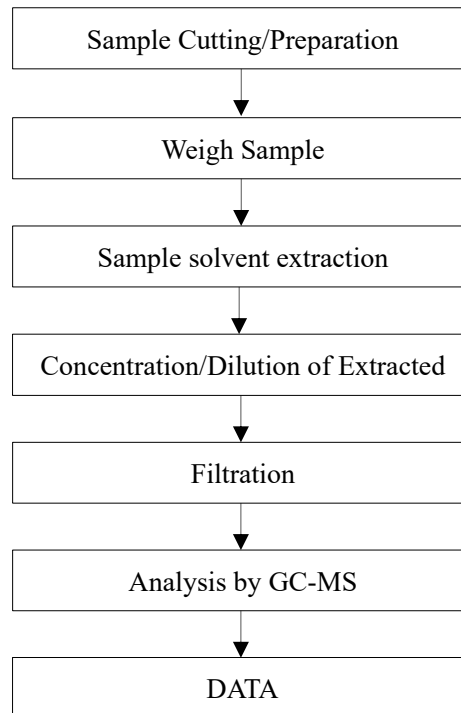
