The cell consists of the positive electrode plate, negative electrode plate, separator, electrolyte and case. The positive and negative electrode plates are housed in the case in the state being separated by the separator.

There are two kinds of cell, flat cap and tip cap respectively. The explosion-proof line of these two cells is the same, the only difference between them, is the height of the cell cap. The following test data is from the flat cap cell.

All tests were carried out in the following models: IMR18650-800mAh, IMR18650-1500mAh, and IMR18650-1800mAh.
