






Figure 5 Front view of cell (IMR18650-2500mAh)




Figure 7 Front view of cell (IMR18650-2200mAh)




Figure 11 Front view of cell (IMR18650-1800mAh)




Figure 13 Front view of cell (IMR18650-1500mAh)
